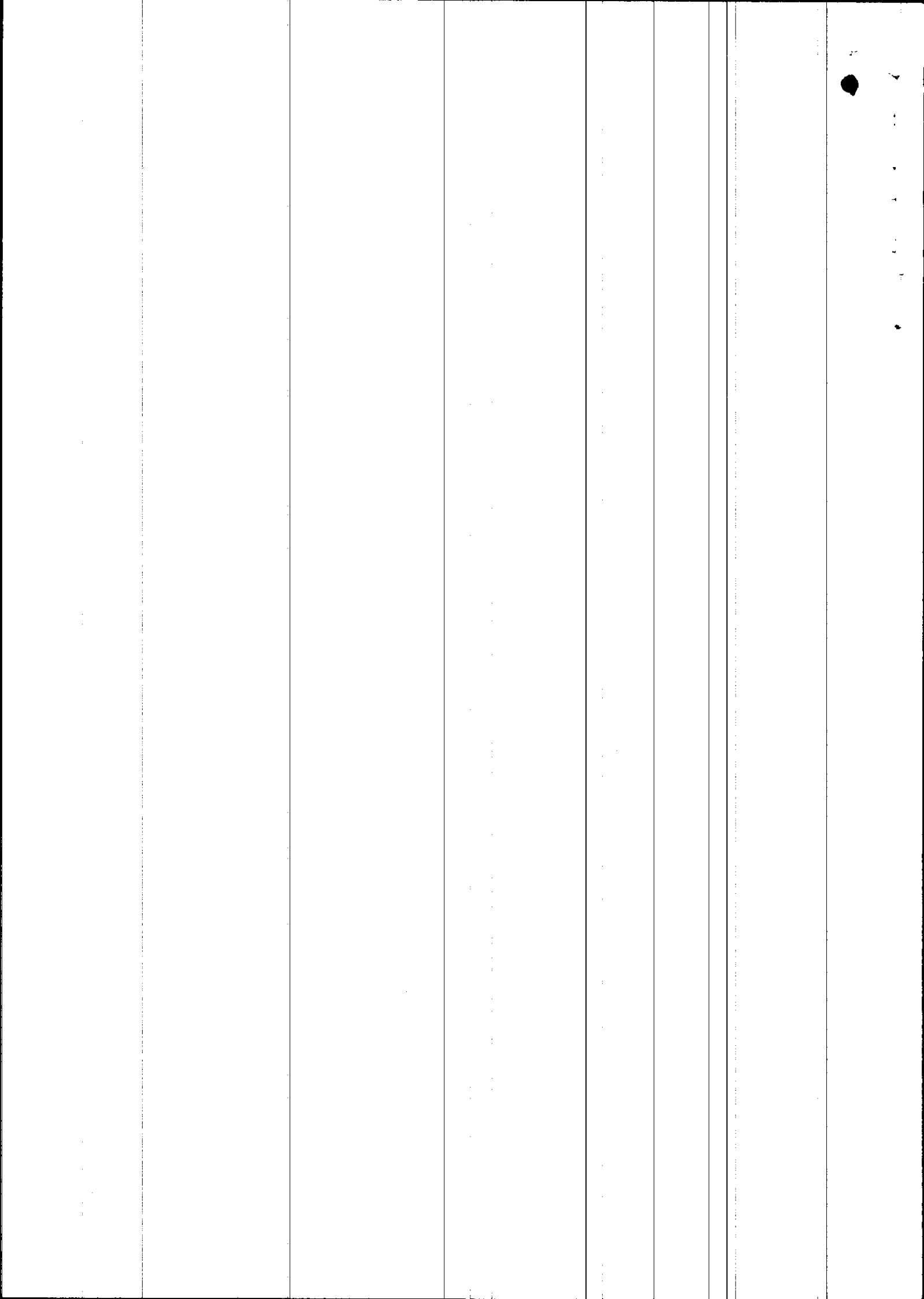
NOTIFICATION
