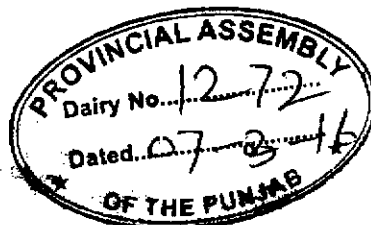
AND WHEREAS the above mentioned Member has now filed the statements of assets and liabilities and has fulfilled the legal requirement.


