- 3. Mr Muhammad Asif Balal Lodhi, Secretary Law and Parliamentary Affairs Department and Mr Shaukat Ali, Secretary (Services), S&GAD, Government of the Punjab represented their Departments as Expert Advisors. Mr Khalid Mahmood, Director General (Parliamentary Affairs & Research), Provincial Assembly of the Punjab functioned as Secretary to the Committee.
- 4. The Committee considered the subject motion and heard the viewpoints of the Mover & the accused officer, Assistant Commissioner. The mover had claimed that the said officer had not responded to his repeated calls which he had made for addressing public issue of urgent nature. The accused officer stated that he could not attend the calls owing to his official engagement, however, he assured the Committee to be careful in future. Secretary (Services) S&GAD, Government of the Punjab, also assured the Committee that in future no such inconvenience would be faced by the Members. The Committee observed that the government's officers must honour and cooperate with the Members of the Assembly and must respond to their calls. The members of the Committee requested the mover to accept the explanation of the accused officer and not to press his privilege motion.

- 5. After detailed discussion, the Committee unanimously observed as under:
 - (i) a comprehensive circular containing SoPs for dealing with the Hon'ble Members of the Assembly be issued by the concerned Authorities to all the officers/officials of the Government of the Punjab; and
 - (ii) the legal provisions regarding the Privileges of Members of the Provincial Assembly of the Punjab must also be circulated to all the concerned.
- 6. With these observations, the Committee unanimously recommended that the Privilege Motion No. 35 OF 2024 be treated as disposed of.
